In view of the global merger of E. I. du Pont de Nemours and Company and The Dow Chemical Company on the 1st of September 2017, it has been decided that all the assets and liabilities of Dow AgroSciences Southern Africa (Pty) Ltd will vest in the South African entity– Dow Southern Africa (Pty) Ltd with registration number 1995/002025/07.

As such, we request that the Water Use Licence Application in respect of the Canelands Site together with the Remediation Order be transferred to Dow Southern Africa (Pty) Ltd in name and substance order that Dow Southern Africa (Pty) Ltd may continue its dedicated and effective remediation of the Canelands site in accordance with the remediation order and IWULA made in respect of the site. DWS does not have the power or jurisdiction to transfer this order. At the appropriate time, when Dow Southern Africa (Pty) Ltd communicates its progress with on-site remediation activities (which ideally should take place in the next few months), such request can be conveyed to the DEA.

As such, we request that the Water Use Licence Application in respect of the Canelands Site be transferred to Dow Southern Africa (Pty) Ltd in name and substance order that Dow Southern Africa (Pty) Ltd may continue its dedicated remediation activities in respect of the site.
